Welcome to Shiawassee Health and Wellness (SHW). We are your local agency for Mental Health services. We are a member of the Mid-State Health Network (MSHN), a family of community mental health and substance use disorder providers joined together to give you access to quality care.

This Directory of Providers has been created to help you make informed decisions in selecting a service provider.

"A provider is any organization or licensed independent practitioner currently meeting the credentialing guidelines and who are under contract with SHW to deliver behavioral health services to the persons we serve"

You are probably already working with your current provider to decide what services will work for you and your unique and specific needs. It is up to you to decide who you want to provide the services.

In addition to this Local Provider Choice Listings, a "Your Guide to Services" (aka Consumer Guide to Services) is also available to you in hardcopy or on our website. The "Your Guide to Services" has been prepared for you to provide important information about the services available to residents of Shiawassee County, how to request services, and about your rights and responsibilities as a consumer of mental health services. We believe it is important that consumers of mental health services have information available that will help them make informed choices about the services and supports they will receive, as well as the providers from which they can choose. We believe that these combined documents provide you with valuable information to meet that need.

SHW provides residents of Shiawassee County with Emergency Services 24 hours a day, 7 days a week. This service can be accessed Monday through Friday, 8:00 a.m. to 5:00 p.m., by calling 989-723-6791, or coming directly to our offices at 1555 Industrial Dr., Owosso, MI. Emergency Services staff can be reached after business hours, on weekends, and on holidays by calling 1-800-622-4514.

All SHW providers are contractually required to complete Cultural Competency training in accordance with MSHN training requirements. Additionally, provider's offices and facilities are required to accommodate individuals with physical disabilities in accordance with ADA requirements.
